

## CHAPTER 96: PARKS AND RECREATION

### **§96.01 CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN PARK AREA PROHIBITED**

The possession or consumption of alcoholic beverages on any property owned or controlled by the City for park and recreational purposes, whether malt beverages or fortified wine, spirituous liquor or mixed beverages, at any time, is hereby declared to be a violation of the provisions of this chapter, and such conduct is prohibited.

### **§96.02 CONSUMPTION OF TOBACCO PRODUCTS WITHIN PARK AREA PROHIBITED**

The consumption of tobacco products on any property owned or controlled by the City for park and recreational purposes, whether the tobacco is for smoking or other use, at any time, is hereby declared to be a violation of the provisions of this chapter, and such conduct is prohibited. Penalty for violating this section is \$50.00, and no court costs will be assessed.

### **§96.023 PARK HOURS**

Aside from city-sponsored special events, normal park hours for all parks, recreational areas, and playground areas owned and/or operated by the city shall be between 7:30am and 10:00pm, at which time the parks, recreational areas and playground areas shall be opened and closed respectively; and between the hours of 10:00pm and 7:30am on the following it shall be unlawful

for any person to be or remain on said property owned or occupied by the city for park and recreational purpose.

#### **§96.034 PARKING RESTRICTIONS ON PROPERTY ON PARK DRIVE**

It shall be unlawful to park a motor vehicle on any property on Park Drive at any point thereon contiguous to property owned by the city and operated by the city for park and recreational purposes between 11:00pm and 8:00am, except vehicles parked in such areas for authorized programs or event occurring on the city property and beginning prior to 11:00pm shall be permitted until 15 minutes after the conclusion of the program or event.

#### **§96.045 POSTING OF NOTICES**

The appropriate notice of the provisions of this chapter stating that the use of the park and recreational areas owned and controlled by the city in violation of this chapter is unlawful shall be posted at conspicuous places upon such city property owned and occupied for such purposes. The provisions of this chapter shall be in effect upon and after posting of such notice on said property or any part thereof.
